**APPELLANT TNT AND MORE, INC.’S
MOTION FOR EXTENSION OF TIME**

Pursuant to Rules 240 and 263(b), SCACR, Appellant TNT and More, Inc. moves this Court for an extension of time for Appellants to file their replies to Respondents’ Initial Brief and their additional designations of matter to be included in the record on appeal.

In support of this motion, TNT sates as follows:

1. On February 11, 2026, TNT timely filed its Initial Brief in this matter.
2. Following three extensions of time which were granted on February 18, 2026, March 16, 2026, and April 14, 2026 respectively, Respondents timely filed their Initial Brief on April 20, 2026. Respondents’ have yet to file their accompanying designation of matter to be

included in the record on appeal.

3. Appellants' replies to Respondents' Initial Brief and accompanying designation of matter are due to be filed and served on April 30, 2026.

4. TNT requests an additional 10 days for Appellants to file and serve their replies and designations of matter. If the Court grants this request, Appellants' reply briefs and designations of matter will be due May 11, 2026.

5. Appellants previously received extensions of time to file and their initial opening briefs, but this is the first extension sought in connection with their reply briefs.

6. Good cause exists for this request because of the complexity of the matter, the length of the record, and other professional commitments of counsel, including a brief to the Supreme Court due to be filed and served on May 1, 2026, as well as depositions which were scheduled well in advance of this filing date.

7. This request is made in good faith and not for purposes of delay. Respondents and Kettner will not be prejudiced by this extension.

Appellant TNT and More, Inc. therefore requests that the Court grant this motion and extend the time for filing Appellants' reply briefs and designations of matter to be included in the record on appeal until May 11, 2026.
