On October 7, 2025, Respondent filed a motion to dismiss this appeal for Appellants failure to comply with Rule 210(a) of the South Carolina Appellate Court Rules. On December 3, 2025, this court denied Respondent's motion but required Appellant to serve Respondent with a copy of the record on appeal and file the proof of service of the record with this court. On December 5, 2025,
