

We wish you and your always helpful staff a joyous Holiday season.

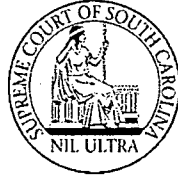

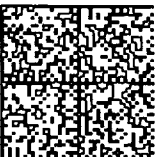
