Please accept this correspondence as a Supplemental Notice in Support of my pending Motion to Reinstate Appeal.

I respectfully notify the Court that the dismissal of Appeal No. 2025-002484 appears to be based on a clerical or administrative error. The \$250.00 filing fee was timely submitted by Western Union money order, reference number 19-820460234. However, the Court's receipt reflects that the payment was applied to Case No. 2026-000660, rather than the correct appeal, Case No. 2025-002484.

The Court's receipt, Receipt No. 107821, confirms payment of \$250.00 by money order dated 04/06/2026. The mailing was also received by the Court on or about April 9, 2026.

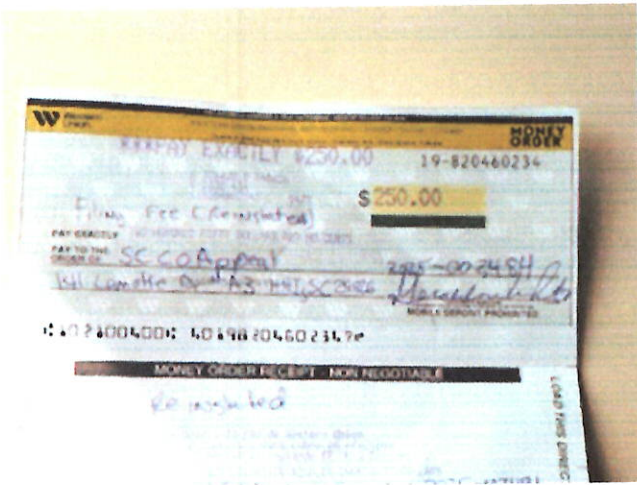
