
INDICTMENT

At a Court of General Sessions, convened on July 16, 2025, the Grand Jurors of Horry County present upon their oath:

**Burglary, First Degree**  
CDR: 0079 16-11-0311

The defendant, Alejandro Luis Diaz, did on or about February 14, 2025, in Horry County, South Carolina, enter a dwelling belonging to Tomar Washington without consent and with intent to commit a crime therein; in addition, the defendant while in the dwelling caused physical injury to a person who was not a participant in the crime, and displayed what was or appeared to be a knife, pistol, revolver, rifle, shotgun, machine gun, or other firearm, and/or used or threatened use of a dangerous instrument, and/or was armed with a deadly weapon, and entered or remained in the dwelling during the nighttime, all in violation of 16-11-0311, *Code of Laws of South Carolina* (1976, as amended).

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
