AMENDED NOTICE OF APPEAL

Antonio Jamari Isaac pled guilty to Assault and Battery 1st degree (2 counts) on August 4, 2025 before Judge Walton J. McLeod, IV. On indictment 2023-GS-02-01732, he received a sentence of 10 years with credit for 890 days. On indictment 2023-GS-02-01733, he received a sentence of 5 years with credit for 890 days consecutive. He filed a Motion to Reconsider the Sentences on August 5, 2025. This Motion was taken under advisement by the Court and denied on September 19, 2025.

The defense was not aware of the Order Denying the Motion to Reconsider the Sentences until April 21, 2026. On April 21, 2026, the defense attorney discovered an entry on the public index referencing the Order Denying the Motion to Reconsider and the attorney immediately requested a copy of the Order from the Aiken County Clerk of Court. The Clerk of Court emailed the Order to the defense attorney on April 21, 2026. The Clerk of Court records indicates the Order was provided from the Clerk's office to the Aiken County Public Defenders Office at an unspecified, date however, this defense attorney works in the Barnwell office and never received the Order before April 21, 2026.

Antonio Jamari Isaac is appealing the guilty plea, sentences and the denial of the Motion to Reconsider.
