I am also scheduling surgeries that have been authorized for the month on December.



APPEAL



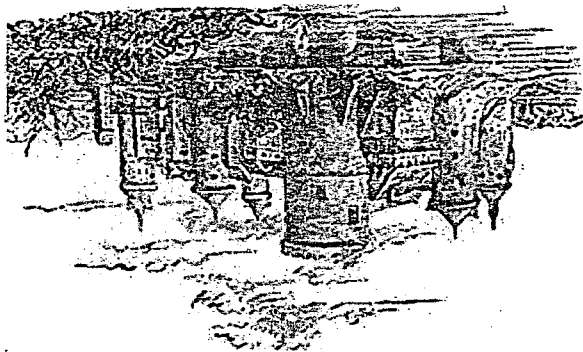


