


ORDER

Respondents in this action filed three separate Respondents' briefs—one on behalf of Wild Wing Company, LLC, Sunstar, LLC, SLF IV/SBI JV, LLC, SLF IV/SBI Properties MM LLC, SLF IV/SBI Development Holdings, LLC, Wild Wing Residential Development, LLC, SB Investments LLC, Realstar Management, LLC, Founders Wild Wing, LLC, Founders Group International, LLC, and Dan Liu (Declarant Respondents); one on behalf of Respondents Graeme T. Black, H. Gilford Edwards, Rick Schultz, Rick Taylor, Thomas Plankers, and Ralph R. Teal, Jr. (Individual Respondents); and one on behalf of Stratford Land Manager, L.P.

d/b/a Stratford Land and Stratford Land Fund IV , L.P (Stratford Respondents). Declarant Respondents have now filed four separate motions for costs; Individual Respondents have filed two; and Stratford Respondents have filed one. All motions assert that separate counsel was required from the other Respondents, and all seek the full \$2,500.00 allowed for attorneys' fees pursuant to Rule 222 of the South Carolina Appellate Court Rules. As no oral argument was held in this case and multiple parties joined each brief, we find it is appropriate to award costs of \$2,500.00 per Respondents' brief.

Therefore, pursuant to Rule 222, SCACR, the motion for costs filed by Wild Wing Company, LLC and Sunstar, LLC, is granted in the amount of \$833.33 against C. Barry Dykes and Barbara Eisenhardt. The lower court or tribunal is directed to add this award of costs to the remittitur.
