MOTION FOR ENLARGEMENT OF TIME
TO CURE/FINALIZE
INFORMA PAUPERIS APPLICATION

ON, APRIL 24, 2026, THE APPELLANT SUBMITTED A MOTION TO PROCEED
INFORMA PAUPERIS WITHOUT PREPAYMENT OF FILING FEES AFFIDAVIT. ABSENT FROM
THE AFFIDAVIT WAS A FINANCIAL STATEMENT FOR THE PAST SIX (6) MONTHS FROM THE
SOUTH CAROLINA DEPARTMENT OF CORRECTIONS. ON APRIL 21, 2026, DEPUTY CLERK
FROM THE COURT OF APPEALS INSTRUCTED APPELLANT HE HAD TEN (10) DAYS TO
CURE DEFICIENCIES WITH SUBMISSION OF FILING FEES AND THE AFOREMENTIONED
MOTION TO PROCEED INFORMA PAUPERIS WAS SUBMITTED IN A TIMELY FASHION.

THE APPELLANT HAS REQUESTED FROM THE SOUTH CAROLINA DEPARTMENT OF
CORRECTIONS (S.C.D.C.) A FINANCIAL STATEMENT, BY WAY OF SCDC FORM 19-11 "REQUEST
TO STAFF MEMBER"; HOWEVER, SCDC POLICY GA-06.04 PROVIDES FORTY-FIVE (45) DAYS
TO REPLY TO REQUESTS. THE REQUEST WAS SUBMITTED ON APRIL 24, 2026 AND WILL
NOT REQUIRE RESPONSE UNTIL JUNE 8, 2026. THEREFORE, THE APPELLANT SUBMITS
THE INSTANT MOTION REQUESTING FOR THE COURT TO ALLOW AT LEAST UNTIL JUNE 15,
2026 FOR APPELLANT TO SUBMIT THE FINANCIAL STATEMENT. ADDITIONALLY, THE
APPELLANT REQUESTS FOR THIS HONORABLE COURT TO PROCEED WITH PROCESSING
HIS APPEAL IN THE INTERIM.
