(SECOND REQUEST)**

Respondents, by and through their undersigned counsel, hereby move pursuant to Rule 263(b), SCACR, for an extension of the time in which to serve and file Respondent's Initial Brief and Designation of Matter to be Included in the Record on Appeal in this case. The grounds for this motion are that there is good cause to grant the requested extension, as the following shows:

1. Upon information and belief, Respondents' initial brief is currently due to this Court on May 15, 2026.
2. 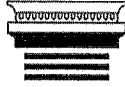


