MOTION FOR AN EXTENSION TO SERVE AND FILE
THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Jeramy Dale Parks respectfully requests a **final thirty (30) day extension** from May 13, 2026 until June 12, 2026 in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Jeramy Dale Parks respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

3. Today, May 13, 2026, counsel had an oral argument in The State v. Dlanor Tilton before the Court of Appeals. On May 8, 2026, counsel filed the initial brief of appellant and designation of matter in The State v. Jason Barnes with the Court of Appeals. On May 4, 2026, counsel filed the petition for writ of certiorari to the Court of Appeals in The State v. Trevor Irvin with the Supreme Court. On April 22, 2026, counsel filed the petition for writ of certiorari and accompanying appendix in Alexis Grant v. The State with the Supreme Court. On April 20, 2026, counsel filed the brief of appellant and designation of matter in The State v. Tyleek Johnson with the Court of Appeals. On April 9, 2026, counsel had an oral argument in The State v. Robert Belcher before the Court of Appeals. On April 7, 2026, counsel had an oral argument in The State v. Antonio Barnes before the Court of Appeals. On March 27, 2026, counsel filed the petition for writ of certiorari and accompanying appendix in Charles Morehouse v. The State with the Supreme Court.

4. Counsel makes this request in good faith and not for purpose of delay.

5. On April 29, 2026, opposing counsel, the Attorney General's office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through June 1, 2026.

WHEREFORE, the undersigned counsel would respectfully request a **final thirty (30) day extension** from May 13, 2026 until June 12, 2026 in which to serve and file the Petition for Writ of Certiorari and Appendix in this case based upon the above exigent circumstances. Counsel requests that time limits for filing the Petition for Writ of Certiorari and Appendix be held in abeyance pending a ruling on this motion.
