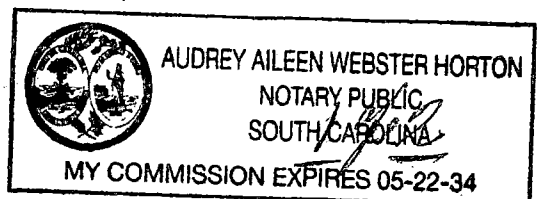



A hearing was held on January 28, 2026, to address the Motions filed by Bobby Joe Barton, Plaintiff and State of South Carolina, Defendant.


