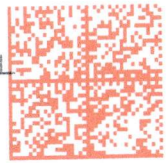

Before deciding whether to plead guilty - a defendant is entitled to The effective assistance of Competent Counsel. Padilla vs Kentucky, 559 US 356, 364 (2010) (internal quotation omitted) Plea Counsel has a duty to conduct an independent investigation Miggins vs Smith 539 U.S. 510, 521-22 (2003). An accused is entitled to Counsel's "considered and reasonable judgement" Simuel vs State, 432 SC 150, 154 S.E.2d 642 644 (Ct App. 2020)

Counsel must conduct a reasonable investigation before making strategic judgments about The course of litigation.
