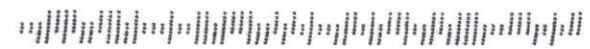

I would like to redact my date of birth, correct name, & social security number in this letter to cure the deficiency under the (SCACR) South Carolina Appellate Court Rules. I was given a website but I don't have access to a computer, law library, & the courts right now. I have ten days from April/6/2026 & today is April/15/2026. If I can't get to the low library to redact my birth date, social security number, & correct name make this letter the evidence to confirm an redact the information to correct without the access I need. I would like to proceed with my appeal with this letter being enough information to correct the deficiency to follow the rules of the SCACR. I don't get any recreation & can't leave my room for medical while sick & injured.
