This is an appeal to the Case # 2023CP4204973 filed in the Spartanburg County court house where I was denied due process after making a payment with a complaint for a civil action lawsuit. I paid \$153.55 for the civil action on file & my case was dismissed without a Jury trial & hearing violating my rights. A hearing & trial date was scheduled and heard without me being present while in jail not giving me a proper hearing. I notified Amy Cox of me being a pretrial detainee & I didn't get transported to go to the trial due to being incarcerated in lockup. My presence in the court was needed & I was denied access to the courts. I have been going through mental health issues while incarcerated so I need a pro bono lawyer to help <sup>from</sup> being physically & mentally ill. I suffer from PTSD from almost losing my life from a deputy, depression from being injured, a broken vertebrae in my neck, a torn rotator cuff that was dislocated that required surgery, & a hurt hip that all has been injuries by the deputies in past events of retaliation. I need help with this issue that I'm being denied a right to a jury trial & the right to confront my accuser about an issue that has left me injured for life with medical bills. I need this case back open so that I can have the rights I paid for. My statute of limitations hasn't ran out being this event happened on 10/18/23 & it's 5/3/26. The statute of limitations is 3 years and I still have time with this appeal. I'm sending a medical bill as proof of my injuries so that this issue won't be over looked to know that I'm really injured.

I **Craig Antonio Ninja Brewton Jr**, am writing this demand letter as my last notice: You currently have an outstanding balance with interest with CB in the amount of **444,000,000**. A Jury trial is **demanded** for the harassment and beating of an unarmed black man on October 2023.

In order to resolve this manner, we have provided the following payment options

If there is no response to this letter, all legal rights shall be explored including, but not limited to, legal proceedings necessary to recover outstanding debt without further notice of this debt may be a collection's agency in accordance with state and federal laws.

This demand letter is for payment serves as an official notice to you and <sup>May</sup> ~~be~~ be tendered in court as evidence of your failure to pay. If legal action is to occur to resolve this matter, it will involve having you <sup>as</sup> ~~pay~~ attorney's fees, hospital bills, punitive damages, and may impact your credit history.

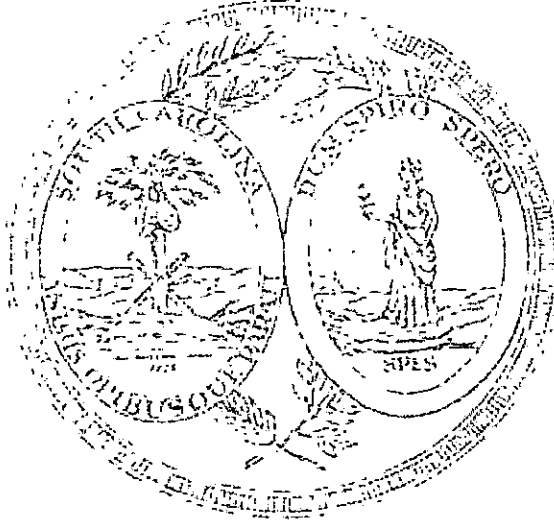
