APPELLANT MOTION FOR EXTENSION OF TIME

Appellant/Respondent moves this Court, pursuant to Rules 240, SCACR for motions in general and Rule 263, SCACR for an extension of time to pay filing for for Appellant's Motion for to file the Proposed substitue Brief. The Appells pursuant to the stated rules of the South Carolina Appellate Court Rules ("SCACR"), is requesting an Order enlarging the time to pay the filing fee, due today, May 14, 2026.
