Will you be in the HOH office this week? Our office will be closed beginning the week of the 22nd through the new year - so all appointments will need to be conducted at Flagship.

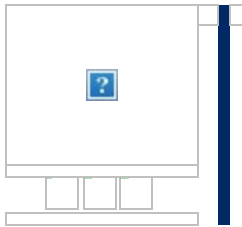

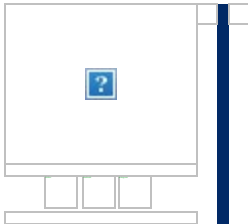
