ORDER DENYING MOTION

On April 14, 2026, a hearing was held to address a motion filed by Larry Anthony White, Jr., requesting a "Franks Hearing." This request is based upon the case of *Franks v. Delaware*, 438 U.S. 154. The hearing was held in the Court's Sealed Virtual Courtroom. Mr. White represented himself, and Deputy Solicitor David Richardson appeared for the State.

This matter stems from a case that began with the shooting of an individual, Terrance Williams, in Marion County, South Carolina, on or about December 22, 2016. Mr. White was charged with Attempted Murder by the Marion County Sheriff's Office on warrant 2017A3310100072 (along with multiple related charges on separate warrants). He was later indicted by the Marion County Grand Jury on July 27, 2017, for the offenses Attempted Murder, Burglary First Degree, Armed Robbery, Kidnapping (x2), Possession of a Weapon During a Violent Crime, and Conspiracy. Mr. White pled guilty, thereby waiving his rights to a jury trial, to Attempted Murder and Burglary First Degree on July 30, 2018, and received a fifteen-year concurrent sentence.

In this motion and in oral argument, Mr. White takes exception to the wording of the Attempted Murder warrant, wherein the affiant states the victim was shot in "the chest area." Mr. White attached a medical record for the victim, which indicates the gunshot wound was to the abdomen. Mr. White takes the position that this discrepancy by the affiant, Investigator Dewayne Rogers, renders everything that came after – the indictment for Attempted Murder and the guilty plea – illegal, and argues that his plea should be overturned.

At the hearing, the Court considered the written motion and oral arguments made by Mr. White, as described herein, including numerous case citations and recitations of portions of the



United States Constitution. Mr. White made no, or very little, mention of the Burglary 1st Degree charge, nor did he make mention of his guilty plea on that charge.

In response, the State argued that the issue was moot and read the indictment into the record, which makes no mention of injury placement. The State further argued that any issue related to probable cause or good faith or errors in the language of the warrant should have been handled pretrial in a preliminary hearing or a pre-trial motion hearing. Since the Attempted Murder count was true billed by the Grand Jury, the indictment becomes the charging document that brings the matter before the Court for trial or plea. The State further argued that if Mr. White took exception with his lawyer for not providing information and options to him, a Post-Conviction Relief action would be the proper avenue.

After consideration of the arguments of both parties, I respectfully deny Mr. White's motion. The proper time to challenge probable cause in the arrest warrant is prior to indictment and disposition. Mr. White was represented by counsel during the pendency of the case, who could have made said challenges should counsel have deemed them worthy. Any issue with effectiveness of counsel is best handled in a Post-Conviction Relief action. Also, Mr. White waived his rights to a jury trial upon pleading guilty. Mr. Whites motion is therefore denied.

Brief summary of case and comments on person (s) arrested:

That on December 22, 2016 at approximately 12:30 AM, at 122 Belin Court, in the county of Marion, Cerria Shante Grant and two co-defendants did enter the residence of Mr. Terrance Leon Williams without consent. Mr. Williams was shot inside of the residence and Terri Tashea Grant was taken from the residence. Cierra Grant and two co-defendants did take approximately \$300.00 and a work jacket.

On December 22, 2016 I, Det. Dewayne Rogers was contacted by Sgt. Kenny Miller in reference to a gun shot victim. Sgt. Miller advised that the male subject is at Carolina Hospital System ER in Marion. The victim was identified as Terrance Leon Williams and he resided at 122 Belin Ct. in Marion County. I was unable to speak with Mr. Williams do to the fact that he was sedated by the time I arrived at the hospital.

~~I spoke with Dr. Christopher Courban, who advised that Terrance Williams was shot on the upper right side of his abdomen and that the bullet traveled across his body down towards his hip. The bullet missed his spine but caused damages to his internal organs. Cutting one of his arteries causing Terrance to bleed on the inside. Dr. Courban advised that Terrance will be transported to McLeod in Florence and that he never said who shot him.~~

I spoke with Mr. Blonoz Reed III in the lobby of the ER. Mr. Reed stated that he was at his father's residence located on South Highway 41 across from St. James AME church. Mr. Reed stated that he heard a truck outside of the residence blowing the horn and he went outside to see who it was. Mr. Reed stated that he found Terrance sitting behind the wheel and told him that he was shot. Mr. Reed stated that he drove Terrance to the hospital and the only thing that Terrance told him was " man, he shot me, he shot me". Mr. Reed stated that Terrance lives in the white trailer on Belin Ct. and that he does not know where the incident had happened.

While at the residence of Mr. Terrance Williams, I was approached by Mr. Reed, who stated that he has some information in reference to the shooting. Mr. Reed stated that someone was inside of the residence at the time of the shooting. Mr. Reed stated that a Terri Grant was inside of the residence and stayed right down the road on Dorothy's Court. I made contact with Terri Grant at her residence.

Myself and Det. Greg Pike interviewed Terri Grant at the Marion County Sheriff's Office. Terri Grant stated that she was at 122 Belin Ct. with Terrance and three individuals came into the house and shot Terrance. Terri stated that when one of the subjects found her, he was going to shoot her. Terri stated that she heard one of the other subjects say, " no not her, that's my sister ". Terri stated that her sister was one of the individuals that came into the house. Terri stated she was taken from the house in a red in color Dodge Challenger with North Carolina tag EEC-3316 or ECC- 3316. Terri stated that Cierra called their mother (Patricia Grant) to come pick her up from the Amphitheater off of Highway 501.

Myself and Det. Pike interviewed Patricia Grant at the Marion County Sheriff's Office. Ms. Patricia stated that Cierra called her and said, " she needs to come pick up Terri from the

Amphitheater ". Ms. Patricia stated that's when she drove up a a orange in color Dodge Challenger drove away and Terri was walking on the road. Ms. Patricia stated that Terri had on a pair of shorts and a t-shirt. Ms. Patricia stated that she took Terri back to the house on Dorothy's Court.

I received information from the SLED Fusion Center, that the tag (EEC-3316 or ECC-3316) did not match. The information received showed that a North Carolina tag EEC-3617 and vin 2C3CDZAG1GH33669 came back to EAN Holdings (Enterprise Rental). I spoke with Mr. Eric Guthrie (lead rental agent) at the Florence airport. He advised that a Deia Sunshine Darien had rented the red in color Dodge Challenger and that she was past due on returning it.

On December 26, I was contacted by Mr. Guthrie who advised that the car had been returned to Enterprise. I contacted Florence Sheriff's Office and spoke with Lt. Kathleen Streett, who met with me at the Enterprise Terminal. Lt. Streett obtained a search warrant for the vehicle that had been involved in an home invasion. The Dodge Challenger was taken to Florence County Sheriff's Office forensic's processing bay in Effingham.

On January 4, 2016 the search warrant for the red in color Dodge challenger was executed by Florence forensics department. All items collected was transfered to me (Det. Dewayne Rogers) and I placed them into evidence at the Marion County Sheriff's Office.

Therefore, Cierra Shante Grant was charged with Attempted Murder, Burglary 1ST Degree, two Counts of Kidnapping, Conspiracy to Kidnap, Armed Robbery and Possession of a Weapon During the Commission of a Violent Crime.

On December 22, 2016 affidavit(s) were completed and brought before a Judge. On January 5, 2017 a warrant was served for Burglary 1st degree. The remaining warrants were served January 9, 2017.

On January 23, 2017 Cierra Grant was mirandized and a videotaped interview completed. During the interview Cierra Grant admitted to being at the residence and identified Larry Anthony White Jr. and Keith Terrell Charles as the other two subjects.

Cierra Grant stated that she was at her grandmother's house on Dorothy's Court and she called and asked for a ride. Cierra Grant stated that after an hour had passed, they were taking too long and she left the house walking. Cierra stated that she walked to St. James AME church across from Belin Court (old brick church). Cierra Grant stated that they came and picked her up from the church (Larry White).

Cierra Grant then stated that Larry White was driving a orange in color Dodge Challenger and Keith Charles (Keefee) was in the passenger seat. Cierra Grant stated that when they picked her up, they asked if she knew where some weed (marijuana) was at and she told them that the first white trailer on the dirt road. Cierra stated that they went to the trailer and she knocked on the door but no one came to the door. Cierra stated that Larry White was standing behind her and he (Larry White) started knocking on the door.

Cierra Grant stated that she heard the dude (Terrance Williams) put the password in and then he (Larry White) just shot him. Cierra Grant stated that she said, " what the hell ". Stating that Larry White had already ran into the house. Cierra Grant stated that Larry said, " come on come on " and Keith was sitting in the car. Cierra stated that they Keith and herself went in and she saw him (Larry White) holding the gun over Tee Tee (Terri Grant) in

back room. Stating that she told Larry, " no, no that my sister " and Larry said, " what ", " that's my sister ".

Cierra stated that he (Larry) grabbed her and the other dude (Keith) was searching and flipping over stuff. Cierra stated that she was arguing with Larry about the whole situation. Stating that Larry put her in the car and they left the house. Cierra Grant stated that she called her mother (Patricia Grant) to come pick Terri up from the road by the Amphitheater. A complete copy of Cierra Grant's video statement will be attached to this packet.

Larry Anthony White was arrested in Dillon County on January 30, 2017 and then brought to the Marion County Detention Center on January 31, 2017. Larry Anthony White was charged with Attempted Murder, Burglary 1st Degree, two Counts of Kidnapping, Conspiracy to Kidnapping, Armed Robbery and Possession of a Weapon During the Commission of a Violent Crime. Larry Anthony White was taken back to Dillon County Detention and will be taken to SCDC for probation violation. Det. Rogers advised Larry Anthony White Jr. of his rights and he advised that he wanted a lawyer.
