
Dear Court of Appeals;

Thank you for ensuring justice is at the fore front of law.

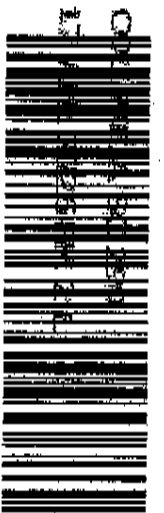

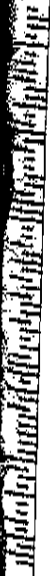
