STATUS REPORT OF APPELLANT

Comes now the Appellant, Aaron E. Quinzy, and respectfully submits the following status update:

1. During the reporting period, Appellant filed motions and related documents in the Master-in-Equity Court and served opposing counsel.
2. Respondents, through counsel, filed a Return to Motion. Appellant thereafter prepared and served a Reply to Plaintiffs' Return to Motion.
3. Appellant recently learned that a hearing was conducted in the Master-in-Equity Court. Appellant was not present because he was unaware that a hearing had been scheduled.
4. Upon learning of the hearing, Appellant contacted the Master-in-Equity office and was informed that notice was believed to have been sent by email on or about April 7, 2026. Appellant searched his email records, inbox, spam folders, trash folders, and related correspondence but has been unable to locate any notice of hearing from either the Court or opposing counsel.
5. Appellant advised the Master-in-Equity office that he did not receive notice of the hearing and would have appeared had notice been received.
6. Appellant was further informed that no final ruling has yet been issued regarding the matters heard and that the Court is awaiting information regarding notice before making a decision. Appellant has reviewed the publicly available docket and has not located any filing reflecting notice of the hearing or service thereof upon Appellant.
7. Appellant continues to actively participate in the proceedings and has filed a written notice regarding the lack of notice of hearing.
8. The underlying appeal remains active, and the lower court proceedings concerning Appellant's motions and related issues remain pending. Appellant respectfully requests that the Court require strict service of all future notices, hearings, scheduling matters, and rulings through multiple methods, including email, U.S. Mail, and any other available means reasonably calculated to provide actual notice. Appellant further respectfully requests that the Court consider vacating, revisiting, or otherwise withholding effect from any actions, rulings, or proceedings conducted without
