This matter is before the Court on Plaintiff's Motion for JNOV or in the alternative Motion for Nisi Additur or New Trial Absolute and Defendants' Motion for Judgment Notwithstanding the Verdict, or in the alternative, for a New Trial Absolute, or in the alternative, for a New Trial Nisi Remittitur. Based on a review of the file, and submissions of the parties, Plaintiff's Motions are respectfully DENIED. Defendants' Motion for Judgment Notwithstanding the Verdict is GRANTED as to the verdict against Defendants Yeargin, Likes, and Pierce on the Civil Conspiracy cause of action. Defendants' remaining motions are respectfully DENIED.

As to Plaintiff's Civil Conspiracy claim, viewing the evidence and all reasonable inferences in the light most favorable to Plaintiff, the Court finds that that the evidence does not yield any inference that Defendants Yeargin, Likes, and Pierce engaged in an unlawful act or lawful act by unlawful means, nor was there any evidence of any separate or overt acts in furtherance of any conspiracy. *Gastineau v. Murphy*, 331 S.C. 565, 568 503 S.E.2d 712, 713 (1998). Therefore, the motion is granted as to the Civil Conspiracy verdict against Defendants Yeargin, Likes, and Pierce.
