

Joey Len Inabinet Jr. appeals his convictions for murder and attempted murder and his sentence. On May 19, 2026, Mr. Black proceeded to trial before the Honorable Walton McLeod, IV and a jury. The jury returned a verdict of guilty on May 22, 2026. Judge McLeod imposed a life sentence for the murder conviction and a sentence of 30 years for the attempted murder conviction, to run concurrently.


