

The Appellant, above-named, would respectfully move this Court for an extension of time within which to file with this Court his *Pro-Se* brief addressing any issues Appellant believes the Court should consider in his appeal. The *Pro-Se* brief in the above case is due to be filed December 16, 2013. Appellant moves that the time for filing be extended to December 31, 2013. This motion is made because Appellant has not had time to complete his brief within the allotted time for the following reasons:

- 1.) The letter from the Clerk of Court's Office was mailed to Appellant on October 31, 2013 at the Lieber Correctional Institution. The Lieber Correctional Institution issued Appellant the correspondence on November 2, 2013. Appellant was subsequently transferred from Lieber Correctional Institution to Broad River Correctional Institution on November 5, 2013, prior to having time to go to law library to file his brief.
- 2.) On November 6, 2013 Appellant's housing unit (Murray) was placed on lockdown status for an alleged gun being inside the building and security measures prevented Appellant from going to the law library from November 6 – 9, 2013. The exact same incident occurred again on November 12-15, 2013 and yet again on November 21, 2013. (During this lock-down status, Appellant was not able to have his legal material in his possession due to the Institution not having property control open as a result of the seriousness of the gun threat. All this information can be affirmed by way of contacting SCDC General Counsel's office.) Thus denying Appellant critical time in which to prepare his *Pro-Se* brief. As a result

the Appellant has not been able, in a timely fashion, to prepare necessary copies and gather information to properly prepare his brief.

Based upon the above stated facts Appellant prays this Court issue and Order granting his Motion to Enlarge Time.



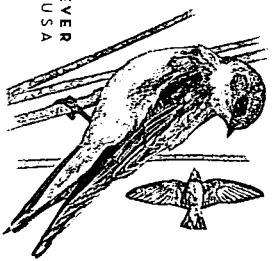
