
Dear Mr. Bowens:

The Court received your letter dated December 9, 2013. The case numbers referenced in your letter, appellate case number 2011-195586, and indictment number 2009GS1005376, both pertain to an appeal that has been remitted. Because the remittitur has been sent, this Court no longer has jurisdiction over those matters.

However, our records indicate you do have an appeal pending at the Court with the appellate case number listed above and the following indictment numbers: 2011GS1002338 and 2011GS1002339. You are represented by Appellate Defender Susan Barber Hackett in this appeal. Because you are represented by counsel, all requests for action by the Court must be submitted by your attorney. *See Miller v. State*, 388 S.C. 347, 347, 697 S.E.2d 527, 527 (2010) ("Since there is no right to 'hybrid representation' that is partially *pro se* and partially by counsel, substantive documents, with the exception of motions to relieve counsel, filed *pro se* by a person represented by counsel are not to be accepted unless submitted by counsel.").
