NOTIFICATION THAT THE TRANSCRIPT HAS NOT BEEN RECEIVED  
AND MOTION TO HOLD APPEAL IN ABEYANCE PENDING RECEIPT

---

Pursuant to Rule 240 of the South Carolina Appellate Court Rules, undersigned counsel respectfully moves this Court for an order holding the timelines for the above-captioned case in abeyance pending receipt of the transcript of the probation revocation hearing from September 12, 2025, before the Honorable R. Lawton McIntosh. The Initial Brief of Appellant and Designation of Matter in this case are due for filing on July 14, 2026. There have been no extensions requested in this case. In support of this request, counsel shows:

1. The July 2024 term of the Bamberg County grand jury indicted appellant for the offense of possession with intent to distribute methamphetamine pursuant to S.C. Code Ann. § 44-53-375 (B) (2024-GS-01-00416). On July 18, 2024, Appellant pled guilty before the Honorable Frank R. Addy, Jr. Appellant was represented by Tristan M. Shaffer, Esquire. Judge Addy sentenced

appellant to a term of eight (8) years' imprisonment, suspended to time served, and three (3) years' probation.

2. On September 12, 2025, Appellant appeared before the Honorable R. Lawton McIntosh for a probation revocation hearing. Appellant was represented by T. Matthew Bradley, Esquire. The court reporter assigned to Judge McIntosh's General Sessions Courtroom was Sharon Hardoon. See Exhibit A. At the conclusion of the hearing, Judge McIntosh revoked Appellant's probation. On July 7, 2025, probation revocation counsel filed a timely Notice of Appeal.

3. This case is now on appeal before this Court.

4. On October 6, 2025, the Office of Appellate Defense ("this Office") ordered the transcript of the September 12, 2025 probation revocation hearing through the South Carolina Judicial Branch Transcript Portal ("the transcript portal"). See Exhibit B. It appears that because Judge McIntosh could was not listed as an option on the drop-down menu to select the proper presiding judge, see Exhibit C, Judge Eugene C. Griffith, Jr. was selected as the presiding judge so that the transcript could be ordered through the portal. Cathy Provost was the court reporter the portal assigned to transcribe the hearing.

5. On January 9, 2026, Court Administration reassigned the production of this transcript to Tara T. Scott. See Exhibit D. This receipt of this transcript request still erroneously listed Judge Griffith as the presiding judge.

6. On March 16, 2026, the transcript of the underlying guilty plea hearing from July 18, 2024 was ordered by this Office through the transcript portal. The court reporter assigned to transcribe this hearing was Tara T. Scott. See Exhibit E.

7. On April 9, 2026, Court Reporter Manager Tammie Holmes filed a Notice with this Court granting an extension to court reporter Tara T. Scott through April 9, 2026 "to prepare and deliver

the Transcript of Record” in this case. The Notice of extension did not note which transcription Ms. Scott was being granted an extension to produce. See Exhibit F.


8. On May 15, 2026, this Office received the transcript of the July 18, 2024 guilty plea hearing from court reporter Penny Johnson. This office then erroneously filed a letter to this Court averring that the transcript had been delivered and requested that the timeline for filing the initial brief of appellant and designation of matter be started from the same day. See Exhibit G.

9. On June 9, 2026, upon information that the transcript of the September 12, 2025 probation revocation hearing had neither been received by this Office nor received by Tara Scott to transcribe, and because the transcript portal still did not display the correct options for the presiding judge, the court reporter, or defense counsel, this Office filed paper transcript request with Court Administration. See Exhibit H.

10. Counsel discovered the fact of the missing transcript early and endeavored to prepare this motion before taking any extensions in appellant’s case.

WHEREFORE, undersigned counsel respectfully requests that this Court hold the above-captioned case in abeyance pending receipt of the outstanding transcript. Counsel also requests that the time limits for filing the initial brief and designation of mater be held in abeyance pending disposition of this motion.
