DESCRIPTION OF OFFENSE:

Drugs / Trafficking in cocaine, 10 g or more, but less than 28 g - 1st offense

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On June 29, 2022 at approx. 2300 hrs, in Colleton County, SC, the defendant Terry Lamont Scriven, committed the offense of Trafficking in Cocaine 10g or more but less than 28g, 1st offense. Contact was made with the defendant during a motor vehicle collision investigation, as he was driving a 1998 Buick Sedan, south on US17 into a ditch. During initial contact the defendant was being transported by EMS for a possible overdose. 2 clear bags containing a white, powdery substance were located. According to Officer McCubbins with the Cottageville PD, the defendant took one bag out of his mouth upon request, and the other bag fell out of his right pants pocket as he was being helped up the ditch by EMS. At the hospital, the defendant admitted to smoking marijuana rubbed in Cocaine and admitted to the 2 bags he had on him to be cocaine. The defendant was placed under arrest for Driving Under the Influence and Possession of Cocaine. The substance weighed 19.9 grams. Trp. Heintl is the investigating Officer.



**Possession with intent to distribute Fentanyl**

That in Colleton County, South Carolina, on or about June 29, 2022, the Defendant, Terry Lamont Scriven, did possess with the intent to manufacture, distribute, dispense, deliver, or purchase Fentanyl, which was a controlled substance classified in Schedule I (b) or (c) which was a narcotic drug, or lysergic acid diethylamide (LSD), or in Schedule II which was a narcotic drug, all in violation of Section 44-53-370(b)(1), et al. of the Codes of Law of South Carolina.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
