**APPELLANTS’ REQUEST FOR EXTENSION OF TIME
IN WHICH TO SERVE AND FILE PETITION FOR WRIT OF CERTIORARI**

Pursuant to Rules 240 and 263, SCACR, Appellants Riverwalk River District Building 6, LLC, Mark Mather, GRH Development Resources, LLC, The Greens of Rock Hill, LLC, and Assured Administration, LLC hereby respectfully move for an extension of time in which to serve and file a Petition for Writ of Certiorari.
