NOTICE OF APPEAL

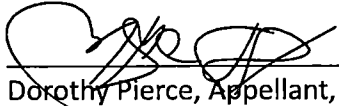

1. The Final Order/Form 4 entered February 17, 2026, denying Plaintiff Dorothy Pierce's Motion to Reconsider, which Appellant received from the Clerk of Court on **May 14, 2026**;
2. The underlying Order Granting Defendants Clements Electrical, Inc., Alton Frederick Clements, Jr., Janet Gay Clements, Jason Dix, Nicholas Behringer, Brandon Durham, and Jeffrey Pilgrim's Motion to Strike Plaintiff Dorothy Pierce's Complaint, which struck Plaintiff Dorothy Pierce's Complaint and dismissed her causes of action;

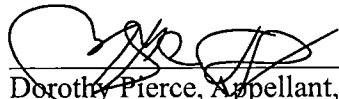

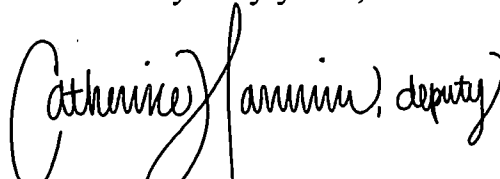
