NOTICE OF APPEAL

Pursuant to S.C. Code Ann. § 15-48-200(a)(3) which specifically authorizes the appeal of any order denying confirmation of an arbitration award, Lifepoint Health d/b/a Providence Health and Providence Hospital LLC (collectively, “Providence”) appeal the Order Denying Motion to Confirm Arbitration Award filed March 6, 2026, (attached hereto as Exhibit A)¹ and the Order filed May 11, 2026, denying Providence’s Motion to Alter or Amend (attached hereto as Exhibit B). Providence received written notice of the entry of the Order denying Providence’s Motion to Alter or Amend on May 11, 2026.

As part of this appeal, Providence also challenges the validity of the Order of the Honorable Daniel Coble dated May 31, 2023, denying Appellants’ Motion to Dismiss or in the Alternative to Enter Final Order filed June 10, 2022 (attached hereto as Exhibit C) and the related Orders of the Honorable L. Casey Manning from August 2021 and November 2021 (attached collectively as Exhibit D). In addition to other reasons, Respondent had filed Articles of Termination before any of these orders had been entered and Respondent presented insufficient evidence to support a retroactive change to this termination of existence.

¹ This Order as well as the Motion to Alter or Amend also denied Appellant the right to conduct any requested discovery on whether Respondent APC’s termination was in error and whether Respondent APC’s “correction” should have been retroactive. These denials are part of this appeal as well.
