EMERGENCY MOTION TO DETERMINE COMPLIANCE, ACCEPT TENDER, AND
PERMIT DEPOSIT OF APPEAL BOND INTO COURT REGISTRY

Defendant/Appellant, Josetta Singleton, appearing pro se, respectfully moves this Court for an Order determining compliance with the Court's bond order, accepting Appellant's tender of payment as timely under the circumstances, and permitting deposit of all appeal bond payments into the Registry of the Court.

In support of this Motion, Appellant states:

1. On May 26, 2026, a hearing was held before this Court regarding bond and stay issues pending appeal.
2. A written order was subsequently entered on June 4, 2026 requiring an appeal bond payment of \$3,977.25 and monthly payments of \$2,494.50 plus utilities.
3. Appellant is a pro se litigant and is not an electronic filer.
4. Appellant relies upon service by mail for receipt of court orders and notices.
5. Appellant did not receive a copy of the Court's signed Order before the June 1, 2026 payment deadline contained therein.
6. Upon learning of the existence of the Order on June 5, 2026, Appellant immediately attempted to tender the required payment.
7. The payment was refused by Plaintiff's representative on the basis that payment was allegedly due on June 1, 2026.
8. Appellant explained that the written Order was not signed and entered until June 4, 2026 and that Appellant had only become aware of the Order on June 5, 2026.
9. Appellant has acted in good faith and has made every effort to comply with the Court's directives.

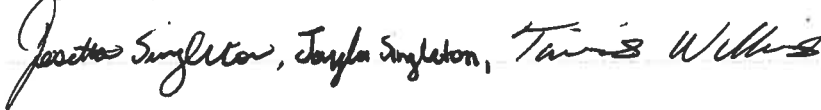

10. Any alleged noncompliance was not willful and resulted from the lack of timely notice of the written Order and Plaintiff's refusal to accept payment after Appellant became aware of the Order.
11. Appellant remains ready, willing, and able to immediately deposit the required funds.
12. Depositing the funds into the Registry of the Court will protect all parties, preserve the status quo, eliminate disputes regarding payment crediting, and ensure compliance pending appellate review.
13. Equity, due process, and fundamental fairness weigh heavily in favor of allowing Appellant to cure any alleged default where Appellant attempted compliance immediately upon receiving notice.

WHEREFORE, Appellant respectfully requests that this Court:

- A. Determine that Appellant acted in good-faith compliance with the Court's Order;
- B. Find that Appellant's attempted tender on June 5, 2026 substantially complied with the Court's requirements;
- C. Permit Appellant to immediately deposit the appeal bond and future monthly bond payments into the Registry of the Court;
- D. Direct that such deposits satisfy all bond obligations pending appeal;
- E. Continue all stays presently in effect;
- F. Grant such other and further relief as the Court deems just and proper.

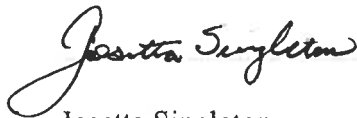
Personally appeared before me, the undersigned Affiant, Josetta Singleton, who being first duly

19. Any alleged noncompliance was not the result of willful disregard of the Court's authority but resulted from the lack of timely notice of the signed Order and AMH's refusal to accept payment once I became aware of the Order.
20. I remain ready, willing, and able to immediately deposit the required funds.
21. Depositing the appeal bond into the Registry of the Court would protect all parties, preserve the status quo, prevent further disputes concerning payment, and ensure compliance while appellate proceedings remain pending.
