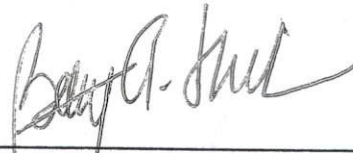
INDICTMENT

At a Court of General Sessions, convened on November 6, 2026, the Grand Jurors of York County present upon their oath:

**OBTAINING GOODS UNDER FALSE PRETENSES, THIRD OR SUBSEQUENT
PROPERTY CRIME**

The defendant, Shannon Renae Hodge, did on or about September 6, 2024, in York County, South Carolina, willfully and unlawfully by false pretense or representation obtain money and/or property valued at more than Two Thousand (\$2,000.00) Dollars but less than Ten Thousand (\$10,000.00) Dollars with the intent to cheat and defraud the victim, Cash Fast. Said Defendant has two or more prior convictions in which the term of imprisonment is contingent upon the value of the property involved. All in violation of 16-13-0240 and 16-1-57 *Code of Laws of South Carolina* (1976, as amended).
