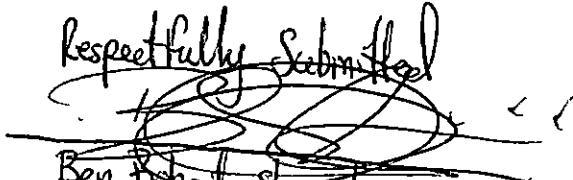
Therefore, to clear this matter, where the attorneys may be disqualified for their improper conduct, the correct defendants are requested

A. says the following in support Motion for a Remand to the Administrative Law Court

1. South Carolina Const. Art 1 § 22 has been denied and deprived where appellant

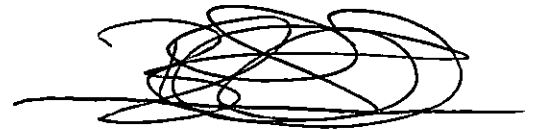

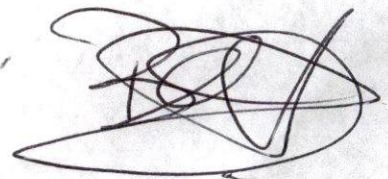
