Hello Mrs. Kitchings,

I Received a Letter on June 1st in concern of an Appeal That was Filed in my case in which I was sentenced to Life Without Parole on January 15th 2025. The Argument That was Mentioned in my Appeal, was That Judge Frank Addy The Residing Judge for my Trial, Allowed a Juror Number #230 To be Selected To sit on the Jury, after being Told, That His Wife Worked in another Court Room for Judge Jefferson. His Wife was Very Familiar With my Case, because I had Filed a Motion To Relieve counsel against my Public Defender and when my motion came before The courts it was Heard by Judge Jefferson.

The Juror's Wife had been in The Court Room as The courts Clerk when my Motion was Heard, My Two Public Defender's Mrs. Rachael ARORA along with MR. William Ted Smith never Objected, OR Questioned The Judge on why That Juror was Allowed to be Chosen as A Juror. Another of Importance, is That I was not Indicted until June, 4th 2024 but my Arrest Date was June, 13th 2020, when I brought This Issue To The Attention of Mrs. ARORA She Told The Prosecutor That I was never Indicted. Mrs ARORA came to The Detention center, and Stated to me I had been indicted back in 2020 when I Requested a copy of That ~~Indictment~~ Indictment, she said That she could not find it in The courts data base for 2020. HOWEVER I Received Two (2) Indictments by Legal Mail That was Dated June, 4th 2024 and was Filed June, 18, 2024 by The clerk of court by This Time, I had been in ~~the~~ Charleston County Detention center for 4 1/2 Years my Rights were Violated a motion was never filed for a Speedy Trial and was never Considered for a Bond.

When I went To Trial And'am The Prosecutor Mrs. Mallory Told The Judge That The Reason why I was not Indicted back in 2020 was because Their was not a Witness for The Grand-Jury, before The Lunch Break, I had Requested a copy of The Impanelment Documents. I was given a Piece of paper with 17 Signatures That had Met on April, 21, 2021, Judge Markley Dennis signed and Dated This Document That Same Day. I understand That This Issue can be Brought Forward as An InEffective Assistance of Counsel if The court of Appeals can bring This as an Argument Please Let me know. Enclosed is a copy of The 17 Signatures from The Grand-Jury, Along with The Indictments That are 4 Years old From my Arrest Date'.
