NOTICE IS HEREBY GIVEN that Plaintiff **Valarie Harrison**, proceeding pro se, hereby appeals to the **South Carolina Court of Appeals** from the final Order of the Honorable B. Alex Hyman, dated **May 9, 2026**, and received by Plaintiff on **May 19, 2026**, dismissing Plaintiff's claims with prejudice, granting Defendants' motion to dismiss, and imposing sanctions.

This appeal is taken from a final order disposing of all claims.

ISSUES PRESENTED FOR REVIEW

1. **Whether the Court abused its discretion in dismissing the case with prejudice** under Rule 41(b) where Plaintiff attempted to proceed with arbitration and did not willfully refuse compliance.
2. **Whether the Court mischaracterized Plaintiff's conduct** as "willful refusal" and "obstructive," where the record reflects efforts to address arbitration classification, fees, and process.
3. **Whether the Court failed to consider material evidence** submitted by Plaintiff, including communications demonstrating good-faith attempts to proceed with arbitration.
4. **Whether dismissal with prejudice was an excessive sanction**, where the Court failed to adequately consider lesser alternatives.
5. **Whether the Court erred in imposing sanctions** based on alleged communication conduct without adequately considering Plaintiff's documented hearing and speech-related limitations affecting communication.

6. **Whether the Court's sanctions ruling violated procedural fairness**, where the determination relied on one-sided submissions without a full evidentiary opportunity for Plaintiff to be heard.

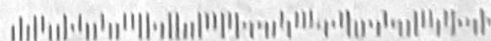
