RESPONDENT'S REPLY TO RETURNS TO MOTION TO DISMISS APPEAL
AND MOTION TO STRIKE DOCUMENT TITLED "PROOF OF SERVICE OF
RECORD ON APPEAL" FILED MAY 26, 2026

Respondent, Lisa Molstad, respectfully submits this reply to the returns filed by Appellants, Sandra Holmwood and Hugh Price, to the Respondent's motions to dismiss the appeal and to strike the document titled "Proof of Service of Record on Appeal" filed May 26, 2026. Respondent rests on the arguments and authorities contained in her motions without repeating them here.

The purpose of this reply is to respond to a single point made in the returns filed by Appellants. They contend they have complied with the Court's letter of May 15, 2026, which gave them 10 days to cure their default in failing to timely serve the record on appeal

and file a proof of service. On the contrary, they did not comply and did not cure their default within 10 days of the Court's May 15 letter by serving the record on appeal and by providing a proof of service documenting actual service of the record on appeal. In fact, they still have not cured their default. Almost six weeks have passed since the May 15 letter. No record on appeal has been served.

The Court should grant both the motion to strike the so-called proof of service, which actually proves nothing, and the Court should grant the motion to dismiss the appeal.

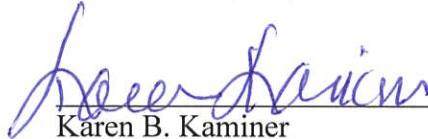
