This matter is before me on a Merit Hearing pursuant to South Carolina Code Section 17-15-55(C). The Court is informed and finds:

- 1) Defendant was most recently confined in the Greenville County Detention Center under warrants **2025A2330211012 (Possessing Methamphetamine, Second Drug Offense); 2025A2330211013 (Possessing Controlled Substance, Second Drug Offense), 2025A2330211015 (Felon Possessing Firearm, Second Offense) and 2025A2330211016 (Possessing Firearm after PWID Conviction)** from an incident occurring in Greenville County on November 4, 2025; and
- 2) At the time of his arrest for these offenses, Defendant was on bond for **Trafficking Methamphetamine (100 Grams or More) (2025A2320200197); Possessing Firearm During Violent Crime (2025A2320200198); PWID Narcotic Substance (2025A2320200199) and Possessing Controlled Substance (2025A2320200200)** from an incident occurring in Laurens County on May 27, 2025.

THE COURT FINDS Defendant was charged with at least one felony offense involving a firearm while on bond for a violent offense and a felony offense involving a firearm that did not arise from the same set of facts. As a matter of law, pursuant to South Carolina Code Section 17-15-55(C)(1), Defendant's bonds for warrants **2025A2320200197-200** are revoked.
