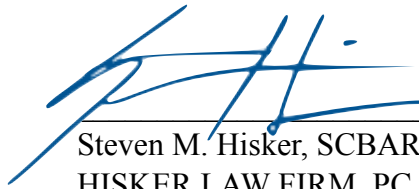
MOTION FOR EXTENSION OF TIME TO REQUEST TRANSCRIPT

The Appellant, by and through undersigned counsel, respectfully moves this Court for an extension of time to request the trial transcript pursuant to Rule 207, SCACR. Appellant was convicted in the Court of General Sessions for Greenville County and a Notice of Appeal has been timely filed. Undersigned counsel represented Appellant at trial and filed the Notice of Appeal in order to preserve Appellant's appellate rights. Undersigned counsel has not been retained or appointed to represent Appellant on appeal. Appellant appears to be indigent and eligible for representation through the South Carolina Office of Appellate Defense. The Office of Appellate Defense cannot assume representation until it receives a completed Affidavit of Indigency from Appellant. Undersigned counsel has forwarded the Affidavit of Indigency to Appellant at the South Carolina Department of Corrections and has requested that it be completed and returned; however, as of the filing of this motion, the affidavit has not been received. The deadline to request the transcript expires on June 25, 2026.

The requested extension is necessary to allow Appellant sufficient time to return the Affidavit of Indigency, permit the Office of Appellate Defense to determine eligibility and

assume representation, and allow appellate counsel to evaluate and order the necessary transcript(s). This request is made in good faith and not for purposes of delay. No party will be prejudiced by the brief extension requested.

WHEREFORE, Appellant respectfully requests that this Court extend the deadline for requesting the transcript by thirty (30) days, or such other period as the Court deems appropriate.
