24 MR. GUESS: Yes, sir.

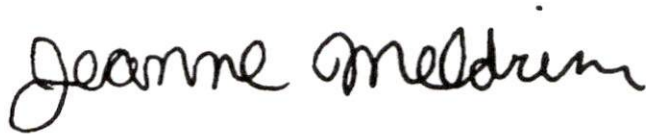
