PETITIONER'S MOTION FOR EXTENSION OF TIME

Pursuant to Rules 240 and 263(b), SCACR, Petitioner Andrew Pampu moves this Court for an extension of time to file his Reply Briefs to Respondents' opposition briefs.

In support of this motion, Pampu states as follows:

1. On April 1, 2026, this court granted Pampu's petition for a writ of certiorari.
2. On May 1, 2026, Pampu timely filed his Final Brief.
3. The Court granted a 20-day extension for Respondents to file their response briefs, which were to be filed June 23, 2026.
4. Respondent Gahagan timely filed his response brief on June 17, 2026. Pampu's current deadline to file a reply to Gahagan's brief is June 29, 2026.

5. Respondents Erin and David Wingo timely filed their joint response brief on June 23, 2026. Pampu's current deadline to file a reply to the Wingos' brief is July 6, 2026.

6. Pampu now requests an additional 17 days to file and serve his reply to Respondent Gahagan's brief, and 10 days to file and serve his reply to Respondents Erin and David Wingo's brief. If the Court grants this request, Pampu's reply to both briefs will be due July 16, 2026.

7. Good cause exists for this request because of the complexity of the matter, the length of the record, the incoming Fourth of July holiday, the separate deadlines to respond to Respondents' briefs which Pampu currently intends to consolidate, and other professional commitments during that time, including previously scheduled hearings and depositions.

8. This request is made in good faith and not for purposes of delay. Respondents will not be prejudiced by this extension.

9. This is Petitioner's first request for an extension before this Court.

Petitioner Andrew Pampu therefore requests that the Court grant this motion and extend the time for filing Petitioner's reply briefs until July 16, 2026.
