At a Court of General Sessions, convened on the 29th day of May, 2026, the Grand Jurors of Greenwood County present upon their oath:

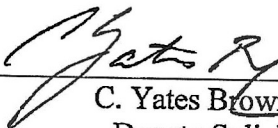
The defendant, Courtney Girele Herring, did on or about August 6, 2022, in Greenwood County, while under the influence of alcohol, drugs, or a combination of alcohol and drugs, drive a motor vehicle and when driving the motor vehicle did an act forbidden by law or did neglect a duty imposed by law in the driving of said vehicle by failing to operate the vehicle in a safe and reasonable manner and failed to maintain proper control of vehicle, which act or neglect proximately caused great bodily injury to Delonte Latrone Simeon Wright, all in violation of Section 56-05-2945(A)(1), Code of Laws of South Carolina (1976, as amended).
