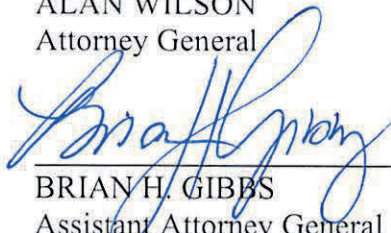
III.
