BANKRUPTCY STATUS UPDATE

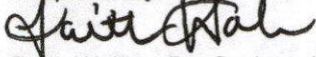
Appellants Faith Walker and Derrick Brown respectfully submit this bankruptcy status update pursuant to the Court's Order dated May 28, 2026.

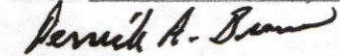

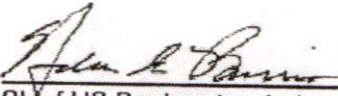

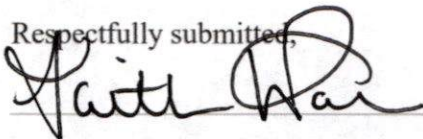
