REQUEST FOR IMMEDIATE RULING REGARDING APPELLANT'S FILING FEE NONCOMPLIANCE

COMES NOW the Plaintiff/Respondent, Zack Alleyne, appearing Pro Se, and respectfully requests that the Court issue a ruling regarding Appellant's compliance with the Court's prior order concerning payment of the filing fee for the Emergency Motion to Stay.

In support of this request, Plaintiff states the following:

1. Appellant filed an Emergency Motion to Stay seeking relief from this Court.
2. The Court ordered Appellant to pay the required filing fee of Two Hundred Fifty Dollars (\$250.00) within fifteen (15) days.
3. Appellant did not pay the filing fee within the time ordered by the Court.
4. Instead of making payment within the fifteen-day period, Appellant filed a Motion for Extension of Time requesting additional time to pay the filing fee.
5. More than three (3) weeks have now passed since the original fifteen-day deadline, and Plaintiff has not received notice that the Motion for Extension of Time has been granted or denied.
6. Plaintiff respectfully submits that continued uncertainty regarding the status of the filing fee and the pending extension has unnecessarily delayed these proceedings and the enforcement of the judgment previously entered in Plaintiff's favor.
7. Plaintiff continues to suffer financial hardship as a result of the continued delay, including ongoing carrying costs, litigation expenses, and the inability to fully enforce the ejectment judgment.
8. Plaintiff respectfully requests that the Court determine whether Appellant has complied with the Court's filing fee requirement and rule upon the pending Motion for Extension of Time without further delay.

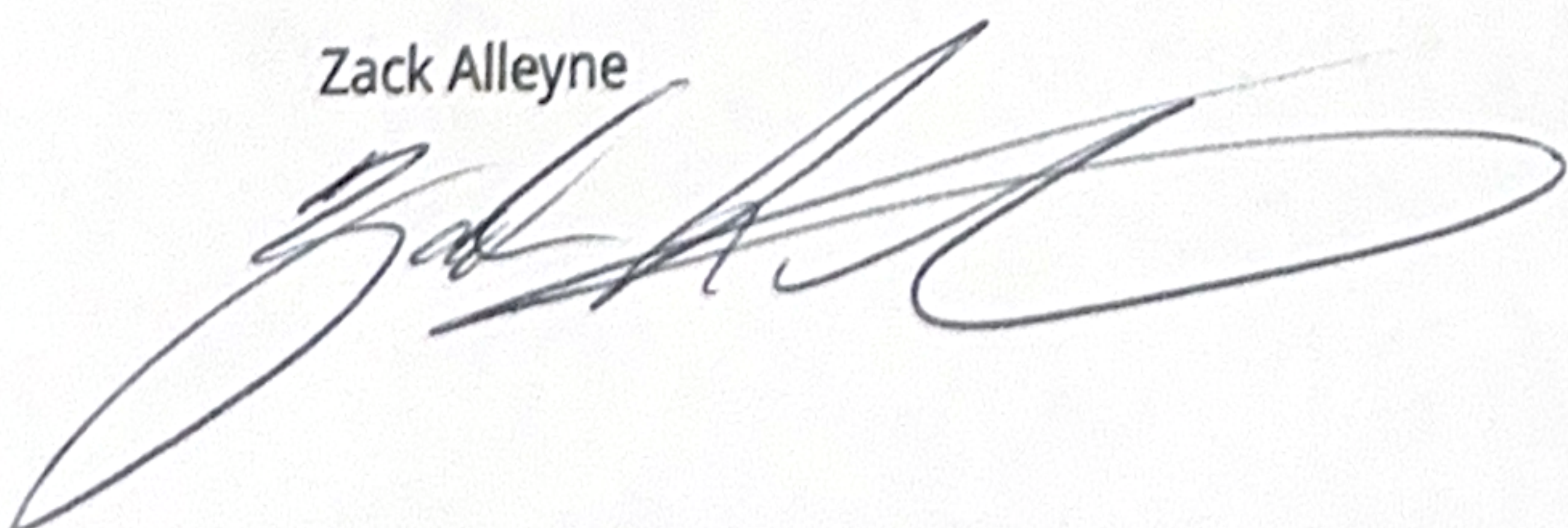
