

NOTICE OF INTENT TO APPEAL

Michael McCraw was convicted after being tried by a jury in his absence of Manufacturing Methamphetamine 3rd offense on October 10th, 2013, before the Honorable Donald B. Hocker in Saluda County General Sessions court and the sentence was sealed. Mr. McCraw's sealed sentence was published on December 2nd, 2013 by the Hon. Thomas Russo. The sentence was 30 years incarceration. Defense counsel filed two post trial motions (motion to reconsider sentence and motion for new trial).
