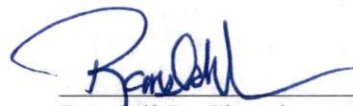

NOTICE OF APPEAL

Leo Lopez III appeals his conviction and sentence in this case. This case was set for trial the week of June 22, 2026. The sentence was imposed by the Honorable Dale E. Van Slambrook on June 26, 2026. The Defendant was convicted of five counts of Unlawful Neglect of a Child and Criminal Sexual Conduct with a Minor, 2nd Degree. The Defendant was sentenced to a term of three years in the South Carolina Department of Corrections for the five counts of Unlawful Neglect of a Child. The Defendant was sentenced to fifteen years in the South Carolina Department of Corrections that provided upon the service of eight years and five years probation for the one count of Criminal Sexual Conduct with a Minor, 2nd Degree. The Defendant also received credit for any jail time served and this added up to one thousand three hundred and three days. All of the charges were to run concurrent with the sentence from June 26, 2026. In addition, the Defendant was also charged with Criminal Sexual Conduct with a Minor or Attempt-Victim Under Eleven Years of Age 1st Degree (Indictment 2025GS0402372) in which the Defendant was found Not Guilty. Furthermore, Indictment 2025GS0402370 was dismissed by prosecutorial discretion and Indictment 2025GS0401724 was a Judicial Dismissal. After the trial, the Defendant contacted his attorney to request the filing of an appeal. Counsel is not aware of any meritorious issues to be reviewed on appeal. However, as Mr. Lopez, has a right to appeal his conviction and has requested that an appeal be filed, I am therefore filing this appeal.

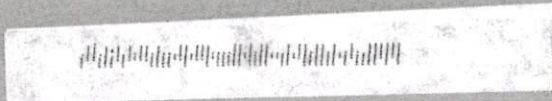
