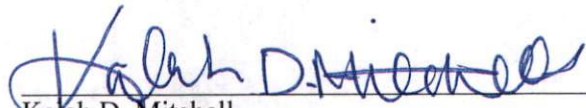

The Appellant received a ninety (90) day sentence with a two thousand one hundred (\$2,100.00) fine suspended on a thirty (30) day sentence with a one thousand one hundred (\$1,100.00) fine with one (1) day credit for time served on Indictment No.: 2025-GS-46-05032. Appellant appealed to the Court of Common Pleas on March 31, 2026. The Court of Common Pleas dismissed the appeal finding there was evidence to support the magistrate's decision. Appellant appeals the decision of the Court of Common Pleas.

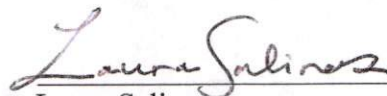
