Motion for Leave to Supplement the Record and for Other Appropriate Relief

Appellants, proceeding pro se, respectfully move this Court for leave to supplement the record with newly discovered evidence and state as follows:

1. After filing the Initial Briefing Statement and Designation of Matter, Appellants discovered a previously overlooked \$500.00 money order dated April 29, 2026.
2. The omission was inadvertent and not intentional.
3. This money order increases the total amount of money orders available from \$6,471.75 to \$6,971.75 and further demonstrates that Appellants had sufficient funds available and made a good-faith effort to comply with the appeal bond requirements.
4. Appellants respectfully request that the Court permit this supplemental information to be included in the appellate record, or grant such other relief as the Court deems appropriate.
5. Additionally, if any funds are presently held by or subject to the control of the Court, Appellants respectfully request that any remaining balance, after satisfaction of any lawful obligations, be applied toward the June and July 2026 utility bills, or that the Court provide such other equitable relief as it deems just and proper.

1. Grant leave to supplement the record with the attached \$500.00 money order dated April 29, 2026;
2. Consider this evidence in evaluating Appellants' good-faith efforts to comply with the appeal bond requirements; and
