Dear Sir or Madam:

It has now been brought to my attention an Order of Dismissal has now been filed concerning my PCR hearing. The "appointed" Hugh W. Welborn of Anderson, has also filed the Appellant's Notice of Appeal; I have no idea what any of that even is, and respectfully ask that an attorney be appointed to me in this matter.

I would also like to clarify about the PCR judges claims in the Order of Dismissal, that the photo was "small." The photo used to tamper with the jury at trial during the act of the "spectator influence" was in fact 12 inches by 12 inches, and in a frame adding an additional 2.5 inches on all sides, giving a total of 289 square inches of influence. This, by far, can not be considered "small," since it was larger than the woman holding it, in width. The photo was taken and preserved as evidence (in the form of a digital scan) for the Appellate Court.

Please also take note, that during the PCR hearing, it became evident at the opening of trial that the attorney assigned to me did not even know who I was. We had never officially met, he refused to see me or answer my questions; and rejected all attempts at communication with me, and my witnesses. I also arranged for witnesses to be present, and he refused to call them to the stand even after I pointed them out as they all sat directly behind us and wished to testify.





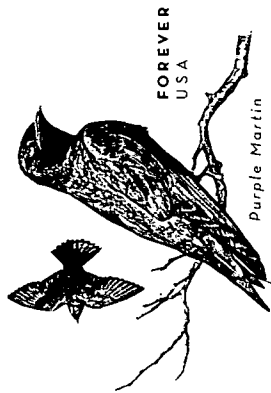
