Dear Ms. Kitchings:

I write to update the Court on the efforts to more specifically identify the video evidence that was used at trial in the Devante White case, as the Court requested in its letter of July 8.

Upon speaking with the assistant solicitor in Beaufort County and reviewing the record, it appears that the State used a composite video with certain effects (highlighting and blurring certain footage) as a sort of demonstrative—which I have reviewed. However, State’s Exhibit 38 comprised all the footage. At the same time, there remain some ambiguities in the record about how the “demonstrative” lined up with what the jury later saw during its deliberations or whether it might have been revised at trial.

At this point, I am inclined to move to supplement the record with the demonstrative and the caveats above. I have spoken with opposing counsel, who has indicated she will likely not have objections to the State’s proposed course of action. However, my supervisor was out of the office last week, and I am scheduled to be out of the office this week. Because I have not had the opportunity to speak with my supervisor, I would request that the court either clarify that the deadline for the parties’ response is July 20, 2026, or provide an extension necessary to make that the deadline.
