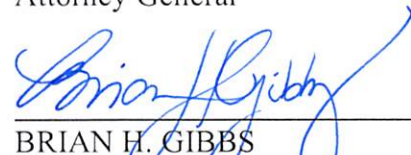
III.

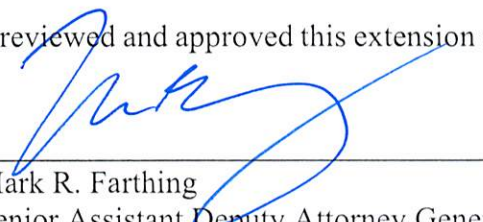
